



Land

Block A shown in red on the plan extends to a total of 107.79 acres, excluding the block of woodland it equates to 99.7 acres (40.37ha). What 3 Words to main access: troubled.learns.meanders

Block B shown in blue on the plan extends to a total of 61.48 acres, excluding the block of woodland it equates to 55.75 acres (22.56ha). What 3 Words to main access: strongly.hang.congested

Tender

Tenders are to be submitted on the attached form and should clearly detail whether you are interested in the whole or Lot A or Lot B. References should be provided.

Grazing Licence

The land will be available to the selected Licensee(s) on a grazing/mowing licence from 1st April 2022 to 30th November 2022. The licence fee will be payable by two instalments (1st April and 1st July) in advance.

The land is available for mowing as necessary; however, the Licensee will be expected to apply fertiliser and/or FYM in an appropriate quantity to replace the nutrients.

No Basic Payment Scheme claim is available in respect of this land.

This land will be available in forthcoming years on an arrangement to be confirmed, please indicate on the tender form whether you would be interested in taking on the land for a longer period.

The land is available for both grazing, mowing or a mix, we kindly ask that parcels 0454 and 1477 are not mown until July due to large number of skylark nesting plots.
